About Hartlepool Information Advice and Support Services

Hartlepool Information Advice and Support Services plays a key role in promoting positive relationships between parents, carers, young people, schools, local authority and others. This is important to enable children and young people with SEND to achieve their potential. Hartlepool IASS will provide support in order to ensure that parents of children and young people with SEND are fully informed and involved in their child's education.

Impartiality

Hartlepool IASS provides an arm's length service from the local authority and clinical Commissioning Groups, offering impartial services to all users by:

- Not favouring one side over the other
- Treating all parties respectfully; and
- Not having any rights or power over the outcome of any discussions or decisions

Confidentiality

Hartlepool IASS provides a confidential service to users. Information about you will **not** be shared outside of the service unless:

- You give permission for the information to be shared, or
- There are strong public interest concerns i.e *safeguarding*

When working with young people separately from their parents the same confidentiality rules apply.
